CHIEF'S REPORT:

Spaghetti Dinner Fund Raiser for Kemitt White – Chief Lurvey reported that between the dinner, silent auction and the auxiliary \$15,800.00 was raised to help Kemitt White with his medical bills.

Personnel – No changes in personnel.

Vehicles-

Engine 111 is out of service due to pump issue. We are waiting on parts for Rupp to fix this.

We have placed the E-One into service as a temporary backup.

Tender 111's portable pool holder was damaged during a fire. We are working on getting San Juan Fabrication to fix it to allow us to put the portable pool back on the Tender.

Grants-

Still waiting to hear back from the State on the Radio grant, but it has been submitted. We have submitted to 50% reimbursement for EMT class that was held by Mesa County. Out of the 4 that attended, 2 passed their written exam before the deadline. The other 2 will have to wait now because the NREMT testing sites have been closed due to the Corona Virus issues.

Budget Items-

We are starting to get PPE for our new personnel. With the State mandates, we might not get anyone to come size us for a while.

Corona Virus Update-

The County EOC and the City of Grand Junction both have been keeping the Fire Chief's informed of the information that has been put out. If you are interested in any of the updated information, the Mesa County Public Health Department website is the best place for information.

The County has issued a No Open Burn Policy due to many factors, but air quality being the main issue with the respiratory virus. This does not affect agricultural burns.
